Old Business

Chief Bridges/ Reserve Policy

Chief Bridges requested acceptance of the Reserve Policy that the BOW had been reviewing. The BOW members discussed that the same training and same expectations would be in place. Brendan Bridges explained that having reserves would also be helpful when holding events. This is a non-paid, voluntary position on both the Reserve Officer and the City of Greensburg.
