Mayor Manus brought up the ARA tax abatement guide and after Council looked it over they decided to table it for now.

Mayor Manus handed out a draft for Holiday's for 2006 for the employees and asks the Council to review them.

Gary Herbert brought up about the trash bins that other people are using and people from out in the county bringing their trash in and putting it at others homes. Gary was real concerned with Franklin and Main Street that has the wooden fence.
