JUNE 6, 2011

Present: Mayor Gary Herbert, Darrell Poling, Herb Hunter, Jamie Cain and Helen Gardner. Bill Wenning was absent.

Pledge of Allegiance was recited.

Roll call was taken with all present.

Minutes were approved motion by Herb Hunter and seconded by Helen Gardner. Ayes Herb Hunter, Darrell Poling, Jamie Cain and Helen Gardner. Nays none. So passed.

City Engineer Gary Murray gave an update on the Lincoln Street and the Broadway Street Projects.

Mayor Herbert opened the Public Hearing meeting for Resolution 2011-4 Annexation Fiscal Plan for furnishing services to the annexed territory within the City of Greensburg and Hunter Robbins Way Road.

There were no comments, Mayor closed the public hearing.

Motion by Darrell Poling and seconded by Helen Gardner to pass Resolution 2011-4 public hearing for annexation. Ayes Jamie Cain, Herb Hunter, Darrell Poling and Helen Gardner. Nays none. So passed.

Motion by Herb Hunter and seconded by Helen Gardner to pass on 2nd reading Ordinance 2011-11 annexing St. Mary's Parcel into the City of Greensburg. Ayes Darrell Poling, Jamie Cain, Herb Hunter and Helen Gardner. Nays none. So passed.

Motion by Jamie Cain and seconded by Darrell Poling to suspend the rules. Ayes Darrell Poling, Herb Hunter, Jamie Cain and Helen Gardner. Nays none. So passed.

Motion by Herb Hunter and seconded by Helen Gardner to pass on 3rd reading Ordinance 2011-11. Ayes Darrell Poling, Jamie Cain, Herb Hunter and Helen Gardner. Nays none. So passed.

After reviewing added information Mr. Mleasko provided concerning the new tax abatements for Valeo and Resolutions 2011-6, 2011-7 2011-8, **motion was made by Darrell Poling and seconded by Jamie Cain to adjust the abatements to 5,3 and 4 years. Ayes Darrell Poling, Jamie Cain, Herb Hunter and Helen Gardner. Nays none. So passed.**

Motion by Darrell Poling and seconded by Jamie Cain to approve tax abatement renewals for Rollin Harpring, Stradley LLC, Tree City Estates, Green Signs, Metz-Tewmey LLC, Family Dental, Hi-Temp, Tree City Cleaners and Wolf Theatre. Ayes Herb Hunter, Darrell Poling, Jamie Cain and Helen Gardner. Nays none. So passed.

Motion by Herb Hunter and seconded by Darrell Poling to pass Resolution 2011-9 STI Tax Abatement personal property 5 years and real estate 10 years. Ayes Jamie Cain, Darrell Poling, Herb Hunter and Helen Gardner. Nays none. So passed.

Motion by Jamie Cain and seconded by Darrell Poling to approve moving insurance money from general into the police equipment. Ayes Herb Hunter, Jamie Cain, Darrell Poling and Helen Gardner. Nays none. So passed.

Councilman Poling wanted to recognize the community of Greensburg for all their help during the recovery from the tornado.

Mayor Herbert stated seven companies have purchased permits for construction since the storm. He asks for all residents to talk with their insurance companies and adjusters first.
