Jamie Cain moved to award **Small Business Center \$5,000.00 from EDIT Funds** and Terry Wagner seconded all ayes no nays, motion passed. Jamie Cain moved to award **\$5,000.00 Big Brother Big Sisters from Riverboat Funds** and Glenn Tebbe seconded all ayes no nays, motion passed. Blake O'Mara moved to award **\$5,000.00 Catch a Ride from Riverboat Funds** and Terry Wagner seconded all ayes no nays, motion passed. Blake O'Mara moved award **\$15,000.00 to New Directions from Riverboat Funds** and Darrell Poling seconded ayes were Blake O'Mara, Darrell Poling, Terry Wagner, Glenn Tebbe and nays were Jamie Cain, motion passed. Additional funding could be awarded to New Directions if need is proven at a later date. Glenn Tebbe moved to award **Economic Development \$60,000.00 from EDIT Funds** and Darrell Poling seconded all ayes no nays, motion passed. Darrell Poling moved to award **\$15,000.00 Greensburg Learning Center from EDIT Funds** and Blake O'Mara seconded all ayes no nays, motion passed. Darrell Poling moved to award **\$30,000.00 to Main Street Greensburg from EDIT Funds** and Blake O'Mara seconded all ayes no nays, motion passed. Darrell Poling moved to award **\$5,000.00 to Bread of Life from Riverboat Funds** and Terry Wagner seconded ayes were Darrell Poling, Terry Wagner, Blake O'Mara, Glenn Tebbe and nays were Jamie Cain, motion passed.

Chris Felger – Horizon Corporation requested property tax abatements for **Fuzion Products LLC** for personal property tax abatement and **Nice Long Nails LLC** for real property. Tax abatement committee reviewed and recommended accepting both abatement requests. Darrell Poling moved to pass **Resolution 2014-2 for Fuzion Products LLC** and Terry Wagner seconded all ayes no nays, motion passed. Terry Wagner moved to pass **Resolution 2014-3 for Nice Long Nails LLC** and Blake O'Mara seconded all ayes no nays, motion passed.

Darrell Poling provided Board of Works meeting report.
