Roll Call was taken

Minutes were approved from the June 6<sup>th</sup>, 2016 Council Meeting. Motion for approval was made by Darrell Poling, seconded by Jamie Cain; voice vote recorded 3 ayes and 1 abstained; motion passed.

### ***Old Business***

*Police Chief Brendan Bridges/ 2<sup>nd</sup> reading of Ordinance #2016-10 amending Ordinance #1996-3/ Fees*

Motion for approval of Ordinance 2016-10 was made by Jamie Cain, seconded by Darrell Poling; voice vote recorded all ayes no nays; motion passed.

### ***New Business***

*Police Chief Brendan Bridges/ Clerk Treasurer Ashlee Green*

Chief Bridges and Clerk Ashlee Green requested that Ordinance #2016-13 amend Salary Ordinance #2015-6. This needed to be amended to include part time clerical help at the Police Station and in the Clerk Treasurer's Office. This would also include adding the 2<sup>nd</sup> mechanic at the Fire Station. This was the 1<sup>st</sup> reading of Ordinance #2016-13. Motion for approval was made by Jamie Cain, seconded by Darren Covington; voice vote recorded all ayes no nays; motion passed.

*Ron May/ 1<sup>st</sup> reading of Ordinance #2016-12, Zoning change at 1314 N. Liberty Circle Dr. West*

Requesting of a zoning change was made at 1314 N. Liberty Circle Dr. West. Roll Call vote was taken for the first reading of #2016-12, voice vote recorded 1 ayes, 3 nays. Motion did not pass. Councilman Jamie Cain requested that we get in contact with this business to discuss this decision with them. Motion for approval was made by Darren Covington, seconded by Jamie Cain; voice vote recorded all ayes no nays; motion passed.

*Mayor Dan Manus/ Fall Festival*

Mayor Manus announced that there will not be a Fall Festival this year, and that there will be a meeting on July 18<sup>th</sup>, 2016 at 6:00 P.M. to get volunteers for next year (2017).

*Ron May/ City of Greensburg Improvement Plan*

Ron May explained the City of Greensburg Maintenance and Improvement Plan. Ron also explained the 2016 Paser rating to the Council. Ron advised the Council that the Gap Analysis Study advised

that if we spend more that we will save in the long run and Ron will give the Council an electronic copy of all of this information as soon as he gets this refined.

*Darrell Poling gave the BOW report.*

*Mayor Manus and Chief Bridges* advised that Greensburg Community Schools received a 1 year grant to have a Police Officer in the Greensburg Junior High. The Police Department may look at hiring another Officer when an Officer is placed in the schools.
