Mayor Manus presented volunteer opportunities for projects in the community prepared by Emily Lowe.


Darrell Poling gave the BOW report.

Darren Covington requested that an appointment be made to the Solid Waste Board.


Vietta McKenzie was appointed to the Solid Waste Board.


