Chief Bridges requested approval of the final reading for Ordinance 2018-4, Criminal Interdiction. Motion for approval was made by Darrell Poling, seconded by Darren Covington; voice vote recorded all ayes no nays; motion passed.

Tax Abatement CF – 1's for Valeo

Greensburg Commercial Warehousing CF-1's, motion for approval made by Darrell Poling, seconded by Jamie Cain; voice vote recorded all ayes no nays; motion passed.

Honda CF-1, motion for approval made by Darrell Poling, seconded by Vietta McKenzie; voice vote recorded all ayes no nays; motion passed.

New SB-1's for Jeff Whitaker: Resolution numbers 2018-11 & 12 for 5 years, motion for approval was made by Darren Covington, seconded by Jamie Cain; voice vote recorded all ayes no nays; motion passed.

New SB-1's for Jeff Whitaker: Resolution #'s 2018-13 and 2018-14 for 10 years, motion for approval was made by Jamie Cain, seconded by Kevin Fleetwood; voice vote recorded all ayes no nays; motion passed. The Council voted to approve 10 year abatements as opposed to 5 year abatements. The Council approved the 10 year abatement for Resolution # 2018-13 because a previous medical practice also received a 10 year abatement. For Resolution # 2018-14 the Council approved for 10 years because it was an improvement along Veteran's Way. The Council requested the Tax Abatement Committee form guidelines for future abatement requests, including the length of abatements that should be approved.


